(Constituted by BCA)

Report-3, Meeting -4

Date: 28.08.2020

The meeting of Affiliation Review Committee (BCA) of the three members was held on 28 August 2020 at Patna Palace, Fraser Road, Patna from 11 AM. The names and designations of the committee members involved in the meeting are as follows:

1. Mr. Saurav Chakraborty – Chairman
2. Mr. Pradeep Kumar Singh- Convener
3. Mr. Sanjay Kumar Mannu- Legal Head (Absent)

The proceedings of the meeting began on the direction of the Chairman of the Committee. All the members gave their views after studying the constitution in force in the BCA on the basis of the documents submitted by the five districts (Bhojpur, Arwal, Bhagalpur, Shekhpura and Jahanabad) and the documents provided by the BCA relating to the said districts.

After discussing on several points, the members unanimously decided according to the category and as per Lodha committee recommendations of districts that:-

1. **Bhagalpur**- Members of the clubs present at the special meeting of the registered clubs of Bhagalpur District Cricket Association on 24th August 2020 raised the issue of all the members of the Working Committee of the District Cricket Association continuing in their posts for more than 15 years and unanimously disqualified the Working Committee. The new committee is being set up in the light of Lodha committee recommendation. Whose names and designations are the following:-

The meeting also urged the BCA to conduct elections under the supervision of bca in Bhagalpur District Cricket Association as per the Constitution. Major Ajit Singh has also been authorized to representation of Bhagalpur DCA in the Special General Meeting of the BCA.

Report: Affiliation Review Committee reviewed the documents of Bhagalpur District Cricket Association provided by BCA and found that all the members of the Working Committee have held positions in the district for over 9 years, due to which the entire committee is disqualified. In view of the proposal made by the newly constituted Committee and the imperative of cricketing activity in the near future, the Affiliation Review Committee recommends continue the affiliation to the newly constituted Committee.

2. **Shekhpura:** The meeting was convened on 02 August 2020 to constitute a committee in accordance with the recommendation of Lodha committee headed by Sheikhpura District Cricket Association vice-president Sanjit Kumar. The important decisions taken in this meeting are:

In the light of the Lodha committee's recommendation disqualifying the three member's President, Secretary and Treasurer of the District Association. They are from being in office bearer from more than two terms, . Therefore, the new committee is being constituted. Which is as follows?

1. President - Dr. Sahjanand Prasad Singh
2. Vice President- Sanjit Kumar
3. Secretary – Santosh Kumar
4. Joint Secretary- Kumar Nagmani Rai
5. Treasurer – Abhay Kumar
6. Club Representative – Kumar Anmol

The meeting also decided to elect the Sheikhpura District Cricket Association committee within 45 days as per the Constitution.

Report: The Affiliation Review Committee reviewed the Sheikhpura district cricket association documents provided by the BCA and found that the three members of the working committee member's (President, Secretary and Treasurer) have been hold their post over six years. Therefore, the Committee disqualifies the three members. In view of the proposal made by the newly constitute Committee and the imperative of


Lodha committee as per the orders of BCA. The important decisions taken in this meeting are:
