

Affiliation Review Committee
(Constituted by BCA)
Report-2, Meeting -3 **Date: 17.08.2020**

The meeting of Affiliation Review Committee (BCA) of the three members was held on 17 August 2020 at Patna Palace, Fraser Road, Patna from 1 PM. The names and designations of the committee members involved in the meeting are as follows:

1. Mr. Saurav Chakraborty – Chairman
2. Mr. Pradeep Kumar Singh- Convener
3. Mr. Sanjay Kumar Mannu- Legal Head

The proceedings of the meeting began on the direction of the Chairman of the Committee. All the members gave their views after studying the constitution in force in the BCA on the basis of the forms submitted by the five districts (Shivhar, Katihar, Munger, Begusarai & Madhubani) and the documents provided by the BCA relating to the said districts.

After discussing on several points, the members unanimously decided according to the category and as per Lodha committee recommendations of districts that:-

After the disqualification of the previous committee in Begusarai DCA, a committee headed by Mr. Vishwjeet Kumar claimed about his committee was formed accordance with Lodha Committee recommendation. After the discussion on his documents and comparing the norms of Lodha committee reforms, the members of Affiliation Review Committee unanimously decided that the committee of Begusarai DCA headed by Mr. Vishwjeet Kumar is qualified and the members of this committee are eligible. All the members of Affiliation Review Committee's unanimously recommend for affiliation of Mr. Vishjit Kumar committee at Begagarai DCA.

The names and designations of the committee members are as follows:

2. Madhubani DCA Mr. Raman Kumar Singh

Two committee's Documents for Madhubani DCA were placed before the committee. One group is headed by Mr Vimal Kumar Singh and another is headed by Mr. Raman Kumar Singh. Parallel cricket activity has been conducted by both factions since 2010. And representatives of both factions were empowered to vote in the BCA elections held in 2015 on the orders of the Supreme Court.

1. The committee headed by Mr. Vimal Kumar Singh has not only violated the order dated 17th October 2018 by the committee of the erstwhile BCA and also did not comply with the Lodha committee's recommendation by the Committee, which falls under the category of contempt of the Supreme Court. The Documents submitted after the election by the committee headed by Mr. Vimal Kumar Singh is not even as per the standard set by the Lodha Committee recommendation.
2. The committee headed by Mr. Vimal Kumar Singh has also not been given any grant by the BCA.
3. The committee headed by Raman Kumar Singh in Madhubani has conducted the election in accordance with Lodha committee in the light of the order dated 17 th October 2018 issued by the BCA.
4. The erstwhile BCA committee had conducted domestic cricket last year by a committee headed by Mr. Raman Kumar Singh, which is to be paid to the BCA.
5. The committee has been reconstituted by Mr. Raman Kumar Singh's committee in the Special General Meeting held on 15 July 2020. The review of the Documents found that the Committee has been constituted under the democratic process as per the recommendation of the Lodha Committee.

All the members of this committee are eligible in the light of lodha committee recommendation. The Affiliation Review committee, therefore, recommends affiliation to the Committee headed by Mr. Raman Kumar Singh of Madhubani District Cricket Association and declaring that the members are eligible as per lodha committee. The names and designations of all the members of this committee are:

Report:

As per record President Mr. Rajiv Kumar Jaiswal of Katihar DCA is disqualified, because he is associated more than 9 years. It is violation of Rules and Regulations of BCA. As per our opinion, BCA shall take suitable action against him, and

instruct to Katihar DCA for further action as per by laws and inform the BCA as soon as possible.

2. Shivhar DCA: President- Shishir Kumar- Shivhar District Cricket Association Secretary and Vice-president are disqualified for serving in government jobs. Since being in government service is a clear violation of the Lodha Committee's recommendation, there is no need to discuss any other point for disqualification of these two.

The Committee, therefore, directs shivhar district cricket association to follow the regular procedure of being a qualified member in the post of Secretary and Vice-President to maintain the affiliation of the district association.

3. Munger DCA: In a unanimous decision taken by the Affiliation Review Committee in its august 9, 2020 meeting, the then Vice-President Shyam Bahadur Singh, the only deserving member of the former committee, was declared eligible. The Affiliation Review Committee had recommended the then Vice-Chairman to meet all the bonded clubs and complete the statutory procedures for constituting the eligible committee in accordance with the recommendation of the Lodha Committee.


It is evident from the forms provided by the BCA that all the bonded clubs of Munger District Cricket Association met the emergency special meeting which was held on 14th August 2020 under the chairmanship of Shyam Bahadur Singh. The meeting constituted a committee of qualified officials in the light of the Lodha Committee's recommendation in munger district cricket association.

The name and designation are the following:

1. President: Shyam Bahadur Singh
2. Vice President: Dharmendra Kumar
3. Secretary: Amitabh Kumar
4. Joint Secretary: Ranjit Kumar
5. Treasurer: Sanjeev Mandal
6. Club Representative: Vinayak Singh

The Affiliation Review Committee found after the review that all members of this committee are eligible. The Committee, therefore, unanimously recommends affiliation to the Committee headed by Mr. Shyam Bahadur Singh.

The remaining [✓] ~~All~~ districts are still under review. These districts will continue to have an earlier position till their review report is completed. Moreover, as various cases/complaints of several district units are pending with the Ombudsman of BCA and/or in court(s), we are of the opinion that it will be the statutory responsibility of the District Associations and BCA to honor their subsequent orders/decisions.
