2019-20	Bihar.C.A	12.12.1999

From the above, it is observed that, this player has been using two different birth certificates in the two consecutive seasons, which is a serious matter and BCCI has dealt with such cases sternly.

Please refer to our letter No.BCCI/HQ/34(J)/2035/2018 dated, 21.06.2018 wherein, we have clearly mentioned that any player found to have submitted tampered birth certificate to the BCCI, shall be disqualified for a period of two years.

In view of this discrepancy in these two birth certificates, we have to advise you that this player is not allowed to participate in any of the BCCI Tournaments for a **period of two years, with effect this season 2019-20.**



It has been brought to our notice that your Association has registered online a player by the name, **Sachin Kumar** (mens' U-23 age group) for 2019-20 season.

While scrutinizing the birth certificates submitted by this player in following years, we have found discrepancy, which is as follows.

2018-19	Bihar.C.A	Govt of Bihar	30.11.1999
2019-20	Bihar.C.A	Govt of Bihar	30.11.1999

From the above, it is observed that, even though the DOB remains constant, however, the birth certificates submitted in three consecutive seasons are issued by two different authorities, as is evident from the copies of the documents submitted by this player to CAB & Bihar Cricket Association.
